	My usual supplier has no masks left in stock. In light of the covid-19 pandemic and the need to implement the right level of protection for my staff, I needed to figure out where to order masks from and exactly what type I need for staff and patients. Reviewed guidance from HPSC and PSI. The guidance on 'the use of surgical masks when healthcare is being provided in the context of the COVID-19 pandemic' was particularly useful as it clarified how to apply the 15 minute rule in practice. I also reviewed NSAI guidance on importing PPE and medical devices for the COVID-19 pandemic and the HPRA guidance on medical devices to ensure the suppliers who were reaching out to me selling these products were compliant with the regulations.

#### **Document Your Learning**

What you have learned. Any new knowledge or skills you have attained. Any additional or future actions that arose through the process.

Once the legislation is implemented, the packaging of medicines will change. There will be two main safety devices implemented on the packaging. There will be an anti-tampering device so that as a pharmacist I can be confident that the medication has not been tampered with. The second safety feature is a 2D barcode that will appear on the packaging that is a unique identifier. This barcode will include a product code, serial number, batch number and expiry.

As a pharmacist I will have to scan these barcodes when dispensing. This will check the system to ensure that this medication is authentic. I will also have to check that the medication has not been tampered. Finally, at the point of supplying to the patient I will scan the medication again to decommission the product, indicating that it has been supplied to a patient.

In order for a pharmacy to be able to comply with this legislation the pharmacy must register with the IMVO.

There will be a 'use and learn' phase first prior to the legislation being enforced. After a period of time this 'use and learn' phase will end.

I now know about my responsibilities under the Falsified Medicines Directive. I know that I am obliged to verify the medicines are authentic and that I must scan these out at the point of supply to the patient. I can also reassure my patients with this change in packaging that the new packaging will ensure that they are getting real and authentic medications.

I am aware that it will slow down the dispensing process and I will have to train my pharmacy technicians and other staff to ensure that they are following the correct process. This is a process that I will have to audit and review on a regular basis going forward.

	I checked online for guidance from reputable sources as a starting point – PSI, HPSC, HSE, IPU. I found so much information it was a bit overwhelming. Considering that the PSI and IPU guidance documents were specific to pharmacy I started there. This gave me a good grasp on the current situation and I was better equipped to quickly cross-reference and fill in knowledge gaps using the relevant HPSC and HSE guidance. I also discussed with local colleagues to sense check that my approach was correct.

	Having read the guidance I now know the safety systems we need to implement in the pharmacy - one-way system for moving around the shop, stickers on the floor to highlight the 2m distance, Perspex screen at the till, masks for staff, notice on door for patients, sanitisation station, max capacity in the shop at a time managed by staff member. The most important thing I learnt in this process was actually how quickly this situation is evolving. It really highlighted to me the importance of keeping up to date with the guidance as the information can change so quickly.
